

Katun Certified Printer Warranty Policy

Katun Corporation ("Katun") warrants to the purchaser ("Customer") that any refurbished Katun Certified branded printer purchased from Katun (the "Printers"), excluding all consumable components contained therein, will, so long as subjected only to Proper Use, be free from defects in materials and workmanship for a period of two years from date of purchase, or longer if so dictated by local law (the "Warranty Period"). Customer understands that such Printers are used machines and will be refurbished accordingly, however, Customer must understand that these Printers may not meet the standards of a new printer.

Katun warrants that the Printers will operate as intended when (i) the Printer is used and maintained in accordance with the manufacturer's and Katun's recommendations and user manuals; (ii) any consumable component installed in the Printer are used in a manner for which those parts are intended; and (ii) the Printer is stored, installed, maintained and used properly. ("Proper Use")

Any Printer which Katun concludes to have a defect in material or workmanship within the Warranty Period will, at Customer's election and as Customer's exclusive remedy, either be replaced with a comparable product free of charge or provided with an account credit to be applied toward future purchases of Katun products equal to the cost of the Printer. At Katun's discretion, the Customer may be required to return defective Printer to Katun for inspection and evaluation.

Under no circumstances will this warranty apply to a Printer that has been mishandled, or operated, stored or used in a manner inconsistent with Proper Use for such Product. This warranty does not cover damage as a result of accident, natural disasters or events, abuse or unauthorized disassembly, repair or modification to the Printer, or unauthorized disassembly, modification or tampering. This warranty does not cover the Product once it has reached or exceeded its useful life. For purposes of clarity, any such event listed above will automatically void this warranty.

The foregoing warranty does not apply to any OEM products.
